October 14, 2021

Racheal Deatherage was present to discuss the possible change to zoning on a property on county Rd P. They have constructed a Yurt on it and would like to rent it out. County Zoning says it needs to be changed from R1 to RR1. The board table it for later discussion.

Gary Kane is looking for election workers. We need to appoint the board at the December meeting. Bill Eldred was present and expressed interest as did Susan Amys. Gary is compiling a list.

Budget planning meeting Arthur Amys made a motion to have it at 6:00pm prior to our November 11 meeting, Dennis Hill seconded. Motion carried.

Ceiling panels for the hall to reduce echoing, Dennis Hill has been in contact with Shaeffer Acoustics out of Duluth. Gary Kane will call to set up at time to have them out to get a firmer quote.
